The organizing club can, after receipt of the registration forms, limit the number of participants, in order to offer a balanced participation and according to the date of subscription.  
The "planned elements" have to be sent to Mr. Ludo Daemen ([ludod@telenet.be](mailto:ludod@telenet.be)) with copy to the president of VKSB ([secretary.skatebelgium@gmail.com](mailto:secretary.skatebelgium@gmail.com)) and the secretary of VKSB ([mariabouwens@hotmail.com](mailto:mariabouwens@hotmail.com)) at least 4 weeks before the competition.

**Limitations** : The total number of participants can be limited according to the availability of the ice.  
The organizer can, if necessary, split up the categories according to the draw.  
No limitations for the organizing club

### **7. CATEGORIES AND REGULATIONS**

According to the ISU New Judging System

**Regulations according the general regulations for National B competition (free program only.)**

#### **Category 1 : Miniemen**

##### **Free Skating 2.30 min +/- 10 sec**

**A well balanced Free Skating program for Singles girls and boys must contain:**

a) Maximum of 4 jump elements for Girls and Boys. There may be up to two (2) jump combinations or sequences. Jump combinations can contain only two (2) jumps. A jump sequence can contain any number of jumps, but only two most difficult jumps will be counted.

b) There must be a maximum of two (2) spins of a different nature (abbreviation), one of which

must be a spin combination with no change of foot (minimum of six (6) revolutions in total) and one spin with no change of position and no change of foot (minimum of six (6) revolutions in total).

c) There must be a maximum:

for boys and girls of one choreosequence according to isu regulations

The Program Components are only judged in:

- Skating Skills
- Performance/Execution

##### **Levels explanations:**

For Miniemen Singles in all elements, which are subject to Levels, only features up to **Level 2**

will be counted. Any additional features will not count for Level requirements and will be

ignored by the Technical Panel.
