	<u>Time table:</u>	The time table will be sent to you as soon as possible after the closing date. The competition is held in 1 day .
	<u>Reliability:</u>	In accordance with ISU regulations the organising committee accepts no liability for injuries or damages sustained by competitors.
	<u>Entry form & Payments:</u>	<p>The ultimate date entry forms will be accepted is February 28th, 2014. The organizing committee will confirm the registration by mail. Registration fees must be paid before the ultimate pay date which is March 8th. If payments aren't received in full, the organizing club has the right to cancel the entry of the skater(s) concerned.</p> <p>There will be no refund in case of withdraw.</p> <p>Planned Elements must be sent directly to the competition coordinator (ludod@telenet.be) and the regional and national secretary (mariabouwens@hotmail.com), secretary.skatebelgium@gmail.com</p>
	<u>Limitations:</u>	Due to ISU Judging System, entries will be limited up to the number of participants possible according to the available ice. Entries will be accepted in chronological order. There will be no limitations for the organizing club. The rules related to the categories are stipulated by the Federation.
	<u>Regulations:</u>	<ol style="list-style-type: none"> 1. There is no draw at the time of the competition. This draw will be done by organisation officials before the competition day; 2. The boys category starts before the girls category; 3. Some modifications related to the time table can be done due to organisation circumstance; 4. The music must be handed over at the info-desk 1 hour before the start of the category; 5. All skaters must be at the ice rink at least 1 hour in advance, except the skaters for the first category of the day, they must be at the rink 30 minutes in advance.

B-CATEGORY COMPETITION

(according to the ISU New Judging System)

Miniemen

Free Skating 2.30 min +/- 10 sec

Warming up 4 minutes

A well balanced Free Skating program for Singles girls and boys must contain:

- a) Maximum of 4 jump elements for Girls and Boys. There may be up to two (2) jump combinations or sequences. Jump combinations can contain only two (2) jumps. A jump sequence can contain any number of jumps, but only two most difficult jumps will be counted.
- b) There must be a maximum of two (2) spins of a different nature (abbreviation), one of which must be a spin combination with no change of foot (minimum of six (6) revolutions in total) and one spin with no change of position and no change of foot (minimum of six (6) revolutions in total).
- c) There must be a maximum:
for boys and girls of one choreosequence according to isu regulations

The Program Components are only judged in:

- Skating Skills
- Performance/Execution

Levels explanations:

For Miniemen Singles in all elements, which are subject to Levels, only features up to **Level 2** will be counted. Any additional features will not count for Level requirements and will be ignored by the Technical Panel.
