Limitations : In case the number of entries exceeds the maximum capacity, the participants will be determined by draw on Wednesday October 14^{th} 2020, 20:00 in accordance with the competition regulations. The draw of the rejected entries will be random, regardless the competition type or category. There will be no limitation for the organizing club.

The organizing committee will confirm the participants by mail within one week after the closing date.

5. EXPENSES :

If payments aren't received in full 10 days after the invoice date, the organizing club has the right to cancel or replace the skater(s) concerned.

Timetable : The competition is held on 1 day. The timetable will be send to the clubs after the closing date.

Prizes : In view of the COVID-19, all ceremonies will be off ice and only for the first three places of each category. These first three will receive a trophy. All other participants will receive a medal.

Starting Order : For each category, the starting order will be determined by draw. The draw will be done by computer prior and send to the club secretaries.

Registration : All skaters must register in person at the info-desk at least 1 hour before the start of their warm-up group (first category 30 minutes). The info desk will be in place in the main lobby of the ice rink.

Coaches : Only named coaches on the entry form will receive a badge for entering the restricted zone.

Rules: See national recreational comp and national recreational comp regulations tables.
